

## **MoCTrack Special - Brian Fitzpatrick's Top Ten WORST Votes**

*If you were to go only by Representative Fitzpatrick's press releases and public statements, you'd have an image of his legislative accomplishments that is divorced from reality. He would have you believe he's an independent thinker, and the local press amplifies this by fawning over his every vote against the party line. In reality, though, not a single one of Brian Fitzpatrick's votes against his party have gone anywhere. Mitch McConnell has not allowed a Senate vote on any of those initiatives, and there's no chance of them becoming law. So, when Fitzpatrick plays the maverick, he has absolutely nothing to lose and everything to gain by burnishing his reputation.*

*Let's look past all that. What you will find below is a rundown of ten Fitzpatrick votes, many of which you won't have read about in the news. These ten votes tell you EXACTLY who Brian Fitzpatrick is and what he stands for. And they paint a picture of an opportunistic and loyal Republican intent upon protecting President Trump, who votes to benefit his donors above all else, including his own constituents.*

### **1. NO to Extending Unemployment and Stimulus Payments during the Pandemic**

In response to the coronavirus pandemic, the House has passed legislation to help various sectors of our society in phases. Brian Fitzpatrick was fine with extending the programs to help business ([H.R. 7010](#)), but when the time came to extend help for individuals, Brian Fitzpatrick said [NO](#). In voting against H.R. 6800, our Congressman denied extended unemployment to tens of millions of Americans and kept us all from getting another stimulus payment.

### **2. NO to Protecting People from Pandemic-related Evictions and Foreclosures**

Tens of millions of Americans have lost their jobs and healthcare to this COVID-19 pandemic. H.R. 7301 would have ensured that they did not lose their home as well. That bill would have imposed a yearlong moratorium on foreclosure and evictions. Our Congressman actually voted [NO](#) to this concept twice - once on the bill described above, and a second time when he voted [NO](#) on the Heroes Act, the phase four pandemic relief bill that also contained a foreclosure and eviction moratorium.

### **3. NO to Impeachment**

Our Congressman heavily promotes his past as an FBI Agent who worked on political corruption. His very first actions in congress were to introduce legislation promoting "clean" government. But when he was faced with the ultimate in political corruption, a President who used taxpayer money to threaten and coerce a foreign leader to help his own political campaign, Brian Fitzpatrick refused to uphold his oath of office, and failed to put the constitution of our country above his political ties to his party. When presented with H. Res. 755, Brian Fitzpatrick voted [NO](#) on the Abuse of Power article and he also voted [NO](#) on the Obstruction of Congress article.

### **4. NO to Election Reforms**

H.R. 1 was a broad elections reform package, and would have expanded voter registration, implemented independent redistricting commissions, and instituted new disclosure rules about campaign expenditures by political organizations. Brian Fitzpatrick voted [NO](#). This is part of a pattern of unwillingness to approve election reforms, as Fitzpatrick also voted [NO](#) to H.R. 4617, to mandate disclosure of foreign assistance by candidates; and [NO](#) on H.R. 2722, to provide funding to states to bolster election security.

### **5. NO to Humane Treatment for Detainees**

At the height of the border detainee crisis last summer, the House attempted to pass H.R. 3239, a collection of basic minimum standards that the US government should provide to detainees. Brian

Fitzpatrick voted [NO](#). He said that NO, detainees should not be entitled to medical screenings, soap, and daily showers. Brian Fitzpatrick said NO, we should not provide toothbrushes, toothpaste and sanitary products to the people in over government's care. He said NO to standards related to minimum space per detainee, toilet access and nutrition needs. Brian Fitzpatrick voted against humane treatment of asylum seekers and immigrants.

#### **6. NO to Net Neutrality**

Net Neutrality is the principle that Internet service providers must treat all Internet traffic equally, and not discriminate or charge differently based on user, content or platform. Brian Fitzpatrick said [NO](#) to Net Neutrality, and voted to allow corporations to charge more to consumers, or throttle their internet access, based on the content they access.

#### **7. NO to Disclosure of Corporate Outsourcing**

Brian Fitzpatrick voted to shield corporations from scrutiny when he voted [NO](#) on H.R. 3624. This bill would have required businesses to publicly report how many American jobs they have sent overseas, so consumers could make informed decisions. Fitzpatrick sided with big business, and against his constituents.

#### **8. NO to Protecting Consumers from Bad Credit Reporting Practices**

H.R. 3621 would have revamped the credit reporting process to protect consumers. It would have excluded medical debt from medically necessary procedures from damaging our credit and would have also excluded debt when it was found that a lender engaged in fraudulent practices. Brian Fitzpatrick said [NO](#) to those commonsense protection. He placed similar votes on two related bills, voting [NO](#) to a bill that would have revamped credit agency dispute resolution and data protection, and [NO](#) to another bill that would have strengthened the Consumer Financial Protection Bureau, including restoring a public database of complaints against banks and lenders that had been shut down by the Trump Administration.

#### **9. NO to Protecting Abused Employees from Forced Arbitration**

One of the revelations of the Me Too era has been that employers with patterns of abusive treatment have relied upon forced arbitration employment agreements to shield their repeated wrongdoings from the public. Forced arbitration agreements keep those situations out of the court system and are habitually tilted in favor of corporations against powerless individuals. The House passed H.R. 1432, to nullify employee forced arbitration agreements, but Brian Fitzpatrick voted [NO](#) to helping uncover patterns of abusive employers.

*All of those votes outlined above were from the past two years of Congress, when Brian Fitzpatrick was committed to saying NO to reforms to help his constituents. For the final vote, we want to return to Brian Fitzpatrick's first term in office, when he was amenable to saying YES.*

#### **10. YES to Massive Corporate Tax Cuts**

At the very end of 2017, Brian Fitzpatrick voted [YES](#) to the GOP's Tax Reform Package. That bill slashed corporate taxes, delivered over 80% of the benefits to the 1% - the wealthiest Americans and corporations. This bill also destroyed the ground on which the Affordable Care Act was built and opened the Arctic National Wildlife Reserve to energy exploitation after decades of protection. By slashing tax revenues, it laid the foundation for Republican attacks on Medicare, Medicaid and Social Security.
